## COPYRIGHT: NOTES FOR AUTHORS/COPYRIGHT OWNERS

1. The journal's policy is for the publisher (Society for General Microbiology) to acquire copyright in all articles published where this exists. This is because ownership of copyright by one organization tends to ensure maximum international protection for the author and publisher against infringement, libel or plagiarism. It also enables the publisher to provide for the widest possible dissemination of articles, and to deal efficiently with requests by third parties to reproduce an article, or part of it, in accordance with a general policy which is sensitive both to any relevant changes in international copyright legislation and to the general desirability of encouraging the dissemination of knowledge.

2. To assign copyright to the publisher, the form should be signed by the copyright owner(s) and **the entire form should be returned to the Editorial Office by mail or fax**.
